COASTAL HORIZONS CENTER, INC. ANNOUNCES CORONAVIRUS MEASURES

As the concern of Coronavirus grips our community, please know Coastal Horizons is diligently working to balance the treatment needs of our patients with ensuring we take all necessary steps to mitigate the spread of Covid-19 pathogens. Our organization understands the fluid nature of this pandemic and will maintain communication with those we serve upon guidance from the Department of Health and Human Services and/or the CDC. Current patients are encouraged to ensure they have a working phone number and/or email address on file with Coastal Horizons so we can share any changes in treatment practices.

As an initial step, Coastal Horizons has significantly increased sterilizing practices of community areas, are screening staff and clients for potential exposure to the Coronavirus and have strategies to tailor treatment availability as needed. Coastal Horizons will work with each client around their unique situation to ensure that different treatment options are available, if needed. This includes a menu of options that will be individually explored, to include teletherapy, telephonic communication, temporarily bridging or extending medications, scheduling immuno-compromised clients during nonpeak times, and taking additional precautions when attending home and office visits. Patients are asked to understand that when our team asks additional screening questions or discusses different treatment options, this is to protect everyone's health.

Part of the mission of Coastal Horizons is creating a *healthier community*, and we will use this as a guiding focus moving forward as we weather this pandemic together.
